

Notice of Race Team Sailing Training Regatta



Kerikeri Cruising Club Doves Bay Sunday 17 – Tuesday 19 December 2017

The Organising Authority is the Kerikeri Cruising Club and KYSG in conjunction with the New Zealand Team Sailing Association.

1.0 Rules

- 1.1 The regatta will involve some training but mainly racing. The races will be governed by the 'rules' as defined in the *Racing Rules of Sailing* 2017-2020 including Appendix D
- 1.2 The Yachting New Zealand Safety Regulations Part 1 shall apply.
- 1.3 The "Single Flag Protest Procedure", D2.3(a) shall be used.

2.0 Changes to Racing Rules

The Racing Rules will be changed in accordance with rule 86 as follows:

- 2.1 Sailors are asked to accept umpires' decisions to allow for this regatta to be practically possible.
- 2.2 In Rule D 5.1, change red to yellow.

3.0 Changes to Class Rules

The rules of the 420 class will be changed as follows -: spinnakers and trapezes will not be permitted. Clause 5.2 also changes class rules.

4.0 Eligibility and Entry

- 4.1 The event is open to all sailors interested in teams sailing and wishing to take part in a training regatta.
- 4.2 Teams [or individual sailors wishing to enter] must fill in the entry form attached and send an entry fee of \$60 per sailor to Kerikeri Cruising Club 346 Opito Bay Road Kerikeri. Entries to Kerikeri Cruising Club. [email address info@kerikericruisingclub.org.nz] They will invoice you for the entry fee. If a Team causes Damage to another team's boats etc. they must cover the cost at least up to the value of any Insurance excess before they are allowed to continue racing.
- 4.3 Entry date is December 4-2017 Late entry MAY be considered but will require a late entry fee of \$50 per team.

5.0 Boats and Equipment

5.1 Teams are expected to bring and use their own 420s. Boats will not be exchanged. Teams should bring coaching RIBs if possible. If they need coaches KCC can provide some contact details. Teams unable to supply boats should contact Derry Godbert 407 8058 or godbert@xtra.co.nz for more information.

- 5.2 Boats must be 420 dinghies fitted with NZTSA size coloured mainsails, being 200mm shorter in the leech than a standard main and the size of a Sunburst main when reefed.
- 5.3 The boats will be left at night on KCC-controlled grounds.
- All teams are requested to supply their own red protest and yellow breakdown flags [minimum size 200 X 150 mm] and bailers.
- 5.5 Buoyancy vests must be worn by competitors at all times while afloat.

6.0 Schedule of Events

- 6.1 Registration and weigh in at KCC Doves Bay on Sunday 17 December from 9.30am to 10.30am.
- 6.2 Briefing:

Sunday 17th. December 10.35 at KCC main ramp or marina shed if raining

6.3 Schedule:

<u>Sunday</u> 11.0 till 13.00: A round robin format at which coaches will be able to talk to their teams while racing when convenient. Leading on to normal racing format after lunch [14.00] The club house is open for a 'normal' dinner at which teams are welcome to get together, after sailing about 18.00. <u>Please note on entry form if likely to attend</u>. Cost will be advised.

Monday 18th 09.00 to 15.00 Team racing based on normal team racing format. Sausage sizzle after sailing 17.30 at the club house. Please tell organisers if not attending. Cost incorporated in entry fee.

<u>Tuesday</u> 19th. 9.00 am. Team regatta format. The format will be based on round robins. Racing will stop by 4.0 pm. Followed by a brief presentation.

7.0 Sailing Instructions

The Sailing Instructions maybe available at registration.

8.0 Sailing Area

Will be in Doves Bay or Te Puna inlet.

9.0 Courses to be Sailed

The course will be mainly right hand 'S'.
